

Terms and Conditions

Equities Accounts

Colmex Pro Ltd (hereinafter **“the Company”** or **“Colmex Pro”**) is a financial services company incorporated and registered under the laws of the Republic of Cyprus, with registration no. 260064. Its registered office is located at 117 Makariou III Avenue & Sissifou Street, Quarter of Apostoloi Petrou & Pavlou, 3021 Limassol, Cyprus. The Company is licensed by the Cyprus Securities and Exchange Commission (hereinafter **“CySEC”**), under license no. 123/10 to provide investment services through its electronic trading platform.

A. The Promotion

New clients that will open an equities' trading account with the Company and make a qualifying deposit as indicated in Section 3 below (hereinafter the **“Qualifying Deposit”**) may be eligible to receive a credit of 5% of the qualifying deposit amount into their trading account, up to a maximum of \$500. Participation in the Promotion (hereinafter **“the Promotion”**) and eligibility for the credit are subject to the Terms and Conditions outlined herein (hereinafter the **“Terms”**).
